Advisory Group	Affordable Health Care Coverage Easy Enrollment (EE) Advisory Committee
Advisory Group High Level Description	The EE Advisory Committee will work with their partners from the Colorado Department of Revenue (DOR) and Connect for Health Colorado (C4HCO) to provide the most user-friendly experience possible for individuals who may be eligible for health care coverage. This group will inform how the DOR and C4HCO handle high-level policy decisions and make recommendations on ways of engaging consumers and other stakeholders about potential changes to the EE program.
Advisory Group Charter	<p>The Advisory Committee may address the following issues:</p> <ul style="list-style-type: none"> • Determine the minimum information necessary to collect from state individual income tax forms to identify uninsured individuals and assess their eligibility for enrollment in a health care program • Determine the procedures for transferring tax filer information from DOR to C4HCO • Recommend revisions to the state individual income tax form that are needed to implement EE • Drafting recommended instructions for the individual tax form instruction booklet that explain how to answer the questions added to the tax return form along with the effects of indicating that the tax filer would like the C4HCO to assess for eligibility of uninsured household members • Determine the process for C4HCO to assess potential eligibility for health care coverage and assist with enrollment. • Ensure individuals who are eligible for health care coverage but not currently enrolled are contacted so that they are aware of their coverage options.
