Planning for the End of the PHE

The Public Health Emergency (PHE) is expected to be extended this week into October and extended once again into January. Data conversations regarding Outreach continues with partners on a regular basis.

OE10 Preparation

Marketing & Outreach

The Board reviewed a presentation on <u>Open Enrollment (OE) readiness</u> for Marketing and Outreach. The presentation outlined Marketing strategies, OE messaging, Outreach, and a map of statewide enrollment assistance.

Customer Service Center

For OE 10, approximately 65 contractors will be hired between Faneuil and Connect for Health Colorado to ensure the Service Center will be fully staffed during peak times. Training will begin Monday, September 19, 2022.

Systems Operations

Staff continues to work on the Exchange system as well as the net new system for Colorado Connect. Due to the additional complexity of running two systems, supporting processes are under review to ensure a smooth rollout.

Investment Pool Resolution

Staff presented the updated <u>Investment Strategy</u>. Since the last update provided earlier this year, the investment environment has improved significantly. The presentation included a detailed outline of the updated investment strategy and the local government investment pool (LGIP) recommendation of joining the Colorado Statewide Investment Program (CSIP). SB22-081 Budget

The Board reviewed a <u>presentation</u> on <u>Senate Bill 22-081</u> (SB22-081). SB22-81 directs the Connect for Health Colorado's Board to design a Marketing, Outreach, and Education Campaign. The bill provides Connect for Health Colorado with \$4MM per year, beginning in 2022 and ending in 2028, to fund the campaign. The presentation highlighted guidance, goals, a tentative timeline, and a high-level overview of funding proposals for year one and post public health emergency (PHE) equaling \$850K.

Christy Blakely motioned to recommend the approval of the funding proposal projected at \$850K. Annie Lee seconded the motion.
