Gathering Feedback

- Between November 2021 and February 2022, one on one meetings were scheduled with Board Advisory Group members with the following goals:
 - Clarify the expertise of existing Board Advisory Group members, to better tailor Group agenda items and identify potential gaps to be filled by vacancies.
 - Gain feedback on meeting logistics, including time, date, frequency, and virtual vs in person formats.
 - Gain feedback on prior meetings and the overall efficacy of the Group.
 - Spark ideas for future topics and discussions.



Key Findings

- Significant turnover of members right before COVID-19 when all meetings went virtual = hard to build rapport
- Group contributions not focused enough on impact to C4 and our customers
- Some prior meetings did not provide meaningful opportunities for discussion or feedback to the Board



Recent Improvements

- Onboard new members together
- Potential for one in person meeting per year in the future
- Review C4 mission, strategic plan, and BAG Charter at beginning of meetings
- Ground members in expertise
- Ensure points of discussion are included in policy implementation updates to BAG
- Ensure BAG calendar reflects key Board discussions
- Kevin Patterson to attend as Board liaison
- BAG feedback shared out regularly at Board meetings
