

Serving 1.75M Coloradans, up 40% or 500k



- Covering 1 in 4 Coloradans
- 43% of the state's children
- 43% of births



End of PHE Continuous Coverage

- After more than three years of keeping people covered on Medicaid/CHP+, PHE continuous coverage is ending
- We have continued processing renewals for the last 3+ years, but now we will act on eligibility
- The Dept. is taking the full 12 months to review eligibility of all 1.75M current members (14 mos including notices)
- Starting this May with notices going out starting in March, based on each member's annual renewal month

Keep Coloradans Covered: 3 Key Operational Goals

- 1. Member continuity of coverage
- 2. Member experience, smooth transitions
- 3. Minimize impact to eligibility workers and state staff



- Help all stakeholders understand the magnitude of this movement est. >325k
- Avoid gaps in coverage and the devastating consequences of that
- Help counties with resources and expertise to answer calls, process changes/apps, etc.
- Recognize the affordability challenges for Coloradans moving from Medicaid to Commercial
- Understand everyone's roles and responsibilities EXECUTE
- Successfully navigate est. >325k Coloradans to other affordable coverage

Estimations for 1.75M on Medicaid

Eligible for Employer plans_ (thru self or family) 10% Medicare or Veterans coverage 3%

Qualify for Marketplace financial support 7%

- About 80% of Medicaid & CHP+ members will continue to qualify.
- About 20%, est. >325k, will need to transition to other affordable coverage
- As the C4H Board, consider the importance of the 7% C4H qualification projection & the C4H projected membership growth.

Note: The Department does not have complete information on continuous coverage members who have not completed their verifications. These estimations are based on historical trends and information available on the continuous coverage population, but this population may not exhibit the same trends as prior populations to the same extent.

Estimating >325k (20%) may no longer qualify and will therefore be disenrolled beginning in May and over the 12 months that follow

> Remain Eligible for Medicaid/ CHP+ 80%







Keep Coloradans Covered How Connect for Health can help


- 1. Increase Special Enrollment Period from 60 days to 16 months, like healthcare.gov
