Contract Extension Process for FY24

As no organizations will exceed the \$250k funding amount for board review, our objective is to provide the Board with transparency and awareness around the application process and selected partners.

Applicant Process


- Between Mar. 10 and May 5, Connect for Health Colorado requested Contract Extension applications from certified partners to operate Assistance Sites, Certified Application Counselor locations and Enrollment Centers across the state
- Contract extensions were gathered through a system called SMApply where applicants were able to self serve to update their FY24 work plans, goals, and budgets

C4HCO Review Process

- Application reviews were based on selection criteria published in each respective partner application type as well as consideration of past partnership and deliverables
- Internal Assistance Network staff reviewed extension work plans and negotiated award amounts, working towards budgets of:
 - \$2.75M in total for funded Assistance Sites
 - \$50k in total for Enrollment Center partners

SB81 Supplemental Funding for FY24

Applicant Process

- Between Apr. 13 and May 5, Connect for Health Colorado requested Supplemental Funding applications from current certified partners to design and implement campaigns to reach and educate customers on how to attain and retain their health coverage based on their needs and financial circumstances
- Planned activity goals must include any/all of the following: reducing the number of uninsured, improving health insurance literacy, assisting people who may lose their coverage or need to transition to new coverage
- Applications were also gathered through SMApply

C4HCO Review Process

- Application reviews were based on strength of planned work activities, attainability of intended goals, as well as consideration of past partnership and deliverables
- Internal Assistance Network staff reviewed supplemental funding work plans and negotiated award amounts, working towards the budget of:
 - \$425k in SB81 funding
