Echohawk Lefthand

Kevin Patterson introduced mentee, Echohawk Lefthand, of the <u>Emerging Leaders of Color</u> Fellowship held by the National Academy for State Health Policy (NASHP).

Medicaid to Marketplace Bridge

Staff at the Department of Health Care Policy & Financing (HCPF) provided an <u>update</u> on the public health emergency (PHE) unwind.

Staff at Connect for Health Colorado provided an <u>update</u> on the Medicaid to Marketplace bridge.

State Identity Proofing Question

Connect for Health Colorado has been working closely with HCPF, the Governor's office, and the Office of Information Technology (OIT) to address the issue with state identity verification that affected approximately 1,800 accounts. The issue has since been resolved and of those accounts, 70% have had successful enrollments. Enrollment planning and follow-up for the remaining 30% continues.

Staff presented an <u>update</u> on the Board Advisory Group (BAG), highlighting role breakdown, geographic breakdown, and recruitment. The Committee is currently accepting applications for two vacancies.
