## Medicaid to Marketplace Bridge

Staff at the Department of Health Care Policy & Financing (HCPF) provided an on the public health emergency (PHE) unwind.

- HCPF recently published their August date Point-in-Time data
- Policy notes:
  - Policy to allow long term care individuals an extra 60 days for Medicaid renewals during the Medicaid Unwind.
  - Ex parte policy change: View individual enrollment rather than household enrollment.

Staff at Connect for Health Colorado provided an <u>update</u> on the Medicaid to Marketplace bridge. Clarifying metrics on individual enrollment and household enrollment were provided.

## Friday Health Plans
