Staff presented an <u>update</u> on Open Enrollment metrics, stakeholder feedback, and customer wins from Marketing.

Staff presented an update on Open Enrollment performance metrics from Customer Operations.

### <u>Legislative Update</u>

The Board reviewed a Legislative <u>update</u> which summarized <u>HB24-1035</u>, which the Board has taken a support position on, the restructure of the Board Advisory Group, and welcomed the new Board Advisory Group Chair, Rosie Duran.

### Service Center Roadmap

Staff presented a <u>roadmap</u> of the service center. The presentation highlighted the 2023 Operations timeline and initiatives for 2024.

### Tax Time Enrollment

The Board reviewed an <u>update</u> on Tax Time Enrollment. <u>HB20-1236</u> established the Health Care Coverage Easy Enrollment Program (tax time enrollment) which gives Coloradans the opportunity to check a box on their state tax return to share their information with Connect for Health Colorado and the Department of Health Care Policy & Financing (HCPF) for the purpose of getting health coverage. The presentation highlights the process for Easy Enrollment Customers, the successes of the first 2 years, web presence, and enrollment metrics.

### IV. Executive & Finance

Staff presented an <u>update</u> on enhanced subsidies planning for plan year 2026 (PY26). The presentation highlights additional financial help for Coloradans under the American Rescue Plan Act (ARPA), contingency planning for PY26, the potential financial scenarios, and the projected cash impacts.
